Review of Older Peoples' Housing Services in Cheltenham

Report of the Assistant Director Community Services

1. Summary

- 1.1. Housing services for older people in Cheltenham have undergone a major funding change with the introduction of the government's Supporting People programme.
- 1.2. There has also been an increase in Cheltenham's population of over 65's and particularly over 80's within Gloucestershire Cheltenham recorded the largest number of over 75's and 85+ in Census 2001. At the same time sheltered housing as an option has declined in popularity and the buoyant house price market, introduction of National Care Standards for Residential Homes and changes to revenue funding for housing related support services have culminated in the loss of over 400 residential care beds in Cheltenham's private sector.
- 1.3. Associated agendas directed by central government will also impact on the demand for accommodation based services for Older People. Social Services Departments are to face financial penalties for cases of people blocking beds in hospital once they are medically fit for discharge. This often occurs because people cannot be discharged into accommodation with appropriate levels of support to meet an interim or long term health or social welfare need.
- 1.4. It was felt timely for Social and Community Overview and Scrutiny Committee to review older persons housing services in Cheltenham in light of the changing funding structure for support services and the demand and aspirations for the delivery of accommodation based services. This report introduces issues which have impacted on the delivery of housing services for Older People. Appendix 1 contains background information for detailing context of supply and demand for consideration when presentations from external speakers are made to Committee during the meeting.
- 1.5. Alistair Shute, Commissioning Manager, Supporting People Team will give a presentation on the changes to revenue funding of housing related support services and their impact on Housing Services for Older People across the

County. Mary Aston, Development Director of Rooftop Housing Group will be giving a presentation on the principles of Older Persons' Care Villages.

1.6. **Recommendation**

The Committee is asked to consider this report and the presentations and determine how they may wish to move this agenda forward

2. Background to Supporting People Funding

- 2.1. A process that began with the Lawes and Ealing judgements requiring the segregation of personal care costs from housing benefit with specific reference to sheltered accommodation warden services led to a complete review of the funding of tenancy support services and the amalgamation of a number of funding streams, including Social Housing Management Grant, into the single pot known as Supporting People.
- 2.2. At its simplest the concept to be achieved is that -
 - Personal rent subsidy should be paid through Housing Benefit
 - Tenancy support services are paid through Supporting People
 - Personal support services through care packages, personal allowances and tax credits.
- 2.3. The Supporting People Programme was implemented nationally by the Office of the Deputy Prime Minister ("OPDM"), through 150 Lead Authorities known as Administering Authorities, using a national project management methodology. Gloucestershire County Council is designated as an Administering Authority.
- 2.4. Supporting People is a partnership between the County Council, the six district housing authorities, Probation service and the three Primary Health Care Trusts and the Partnership NHS Trust. These organisations populate the decision making group within Supporting People known as the Commissioning Body.
- 2.5. The Administering Authority is responsible for the financial management of the programme and is therefore accountable for all over/under spends within the programme. If the Commissioning Body fails to heed the Administering Authority's advice, the Administering Authority has the right to veto any financial decision made by the Commissioning Body and inform the ODPM that it has taken such an action.
- 2.6. The Administering Authority has been responsible for paying the Supporting People Grant to service providers since 1st April 2003, in accordance with the interim contracts. These grants will be paid in 12 equal instalments.

3. Profile of the 60+ Population in Gloucestershire and Cheltenham

3.1. County Profile

3.1.1 Older people are the largest group with support needs in the County. In total there are 185,000 over 60's living within Gloucestershire with 8.38% of these

over 75 and 2.14% over 85. It is expected the number of residents over 75 is likely to increase by 10.3% over the next 10 years.

4. Overview of issues identified through review

- 4.1. Reviews of levels of demand and service provision were carried out during 2001 & 2002 for the purposes of developing both the Supporting People Interim Strategy and the Homelessness Strategy. The results of these reviews, relevant to Older Persons' Housing Services, can be seen in Appendix 1. From these reviews and resultant strategies, the following conclusions can be determined:
- 4.1.1 Proportionately funding for older people's tenancy support services has fared comparatively well from the transition to Supporting People funding.
- 4.1.2 The aim is to enable people to remain in their own home for as long as they choose. To this end the council actively promotes the extension of lifetime homes standard to new homes in general and those in regeneration areas in particular. This together with additional resources to extend adaptations, lifeline alarms, falls prevention and similar initiatives is a top priority.

- 4.1.3 Overall the spread of provision is fairly uniform across Gloucestershire in terms of sheltered housing, each district council has a Home Improvement Agency and a Community Alarm Service. However the supply of Extra-Care housing is concentrated in two of the six districts and the number of support units falls well below the central government profile.
- 4.1.4 A Supporting People Programme key aim for the county is to shift investment from provisions such as sheltered housing to more intensive and targeted accommodation support services. This for long term needs could be effectively delivered in the form of Extra Sheltered housing and intermediate care support units, and a more equitable balance between older people living in rented accommodation and home owners.
- 4.2. An emerging form of accommodation provision for the elderly during the 1990s was the concept of "care villages" which bring together a range of services for older people to meet their individual needs ranging from extra care services for the frail elderly to lower support services for those able to support a level of independent living. The development of such a scheme is a complex set of arrangements involving several partners to provide housing, residential care, home care and support through coherent packages for users that are funded from a range of sources. The dwellings are built to lifetimes homes standards so that people may receive increased levels of support should their health or welfare deteriorate, without having to move accommodation. The village schemes also provide personal and community services and facilities on site, including shops; hairdressing salons; computer resources for example.
- 4.3. Local priorities for Older Person's Housing services, resulting from the afore mentioned reviews and strategies and coupled with the analysis of the Housing Needs Survey and local Older Persons' Housing Strategy are:
 - to complete the refurbishment and conversion of existing sheltered housing to provide more extra sheltered housing or intermediate care solutions, and
 - there is a need for more resources to respond to the fact that a high
 proportion of older people over 60 are home owners and unless their level
 of needs entitles them to Home Care services, provided for by Social
 Services, they are left without the low level community based support
 services. The priority is to support them in their own home.
 - there is a shortage of low level floating support services and a growing need to provide support for older people particularly those experiencing dementia.
 - respite care and planning for live-in and older carers.


The attached information is the combined outcomes of reviews undertaken for the purposes of developing the Supporting People Interim Strategy and the Homelessness Review April 2003.

Cheltenham

Profile

At mid 1997 there were 19,000 people living in Cheltenham aged 65 or over. This was nearly one fifth of the population and higher than the national average. By census 2001 this had risen to 24,128 or 22% of the population. Of the six district councils in Gloucestershire Cheltenham has the highest concentration of older people.

Supply

There are 45 schemes providing a total of 1393 homes in sheltered housing with a range of providers including the local authority, housing associations, independent providers and almshouses. Some of the sheltered housing is available for owner

occupation including leaseholder retirement flats which are often available to people aged 55 and over - and one scheme which is shared equity.

A survey of the independent sector in July 2000 indicates that in Cheltenham there are 15 registered nursing homes with a total of 526 bedspaces. All offer intensive support. There are also 32 residential care homes providing a total of 689 bed spaces. There are 5 schemes which offer both nursing and residential care services and have a further 285 bed spaces; 33 of the bedspaces are in residential homes for people with dementia and 45 are nursing homes for people with mental health difficulties.

Soaring residential house prices have seen the closure of 27 homes, with a loss of over 400 bed spaces, a trend which is predicted to continue.

Cheltenham Lifeline Service:

Currently there are 223 council tenant and 655 private customers of the Lifeline service. An additional 16 users are piloting falls detectors.

Home Improvement Agency (Care and Repair Service):

The combined grant from Cheltenham Borough Council and central government in 2001/2 was £93,300 which should enable around 800 job completions. Care and Repair becomes part of the strategy for Supporting People in April 2003.

Care Direct:

Gloucestershire was one of six counties in the first wave roll-out of Care Direct. It saw calls increase from 35 - 145 per week over ten months. Calls related to:

Requests for aids and adaptations - 70%
Money/Benefits/Finance - 4%
Social Care - 3%
Other - 23%

The county has two main web access advice services:

- Doris a database of local facilities and services for older people
- Guide has a listing of over 4,000 local and national services and organisations providing health, social care and disability information and an inter active advice service.
