Alcohol Misuse Amongst Young People Report of the Assistant Director Public Protection

1. Executive Summary and recommendation

- 1.1 The Gloucestershire County Council Health Overview and Scrutiny Committee recently considered a report on alcohol misuse amongst young people. The objective of the project was to consider existing initiatives aimed at reducing alcohol misuse amongst young people in Gloucestershire, identify gaps in service provision and recommend possible initiatives that would improve available services and reduce alcohol misuse. An executive summary of the report is attached as Appendix A.

2. Introduction

2.1 The Gloucestershire County Council's strategic Health Overview and Scrutiny Committee set up a sub group to look into the health damaging effects of alcohol misuse amongst young people. Details of sub group membership, objectives and terms of reference are contained in the appended executive summary.

3. Background

- Alcohol abuse has in recent years progressed rapidly to the top of the national political agenda and is often referred to by the press as 'Britain's binge drinking culture'. There are good reasons for alcohol misuse to feature so prominently as there are clearly identified linkages to personal health problems, associated costs to the National Health Service and increasing crime and antisocial behaviour in our towns and cities.
- 3.2 While the County's report concentrated on the health effects, it is felt that these cannot be disassociated from the other downside of alcohol misuse in respect of crime and disorder and antisocial behaviour, and the greater harm such activities have on the community at large. This has been recognised at a national level with the recent publication of the government's alcohol harm reduction strategy and in this council's own emerging night time economy strategy (for approval at Cabinet on 6 July 2004). It is also likely to feature in the Cheltenham Crime and Disorder Reduction Partnership's crime reduction strategy for 2005-2008.
- Clearly it is in the interests of this authority to support the recommendations of the County Overview and Scrutiny Committee. It is equally in the County's interests to support this authority in implementing the provisions of the Licensing Act 2003 and working towards the key aims of the night time economy strategy. The County Council, as a key stakeholder, has a major part to play in the development of the council's policy statement required under the Act. Its services will also play a major part in the enforcement of their provisions eg Trading Standards in the sale of alcohol to minors, Social Services and Education in health promotion and proof of age initiatives.
