During 2006 the Cheltenham Crime and Disorder Reduction Partnership (CDRP) has already undergone some structural changes to improve efficiency together with radical changes to take into account the requirements imposed on it by Government Office South West (GOSW). The CDRP is still adapting to commissioning work to be done together with the Spending Project software reporting implications, linking into the new way of receiving funding from GOSW via Gloucestershire County Council and the Safer & Stronger Communities Fund as the precursor to the introduction of a Local Area Agreement from 1 April 2007. In addition to this, with the assistance of GOSW the partnership is already taking changes on board re the Government's Respect Agenda linking into how anti-social behaviour is dealt with and imminent changes to the partnership brought about by the Crime & Disorder Act Review conducted in 2004 linked to the Police and Justice Bill which is likely to get Royal Assent in late Autumn 2006. This will mean further radical changes to how CDRP operates and reporting requirements.

In my view, the structure, funding and how the CDRP operates together with reporting requirements in place now, will be totally revamped and enhanced in 2007 so it is my recommendation that any such review at this time by Overview & Scrutiny Committee would be of little or no value and much better placed in March/April 2007 at the earliest.
