

# Social and Community Overview and Scrutiny Committee 8th June 2006

Reference from Cabinet – Extract of Draft Minute The Future for Tenant Participation in Cheltenham – Progress report (agenda item 6)

The Cabinet Member Community Development and Housing introduced this report which had been circulated with the agenda. He explained that at its meeting on 11<sup>th</sup> March the then Cabinet had requested that the recommendations within the consultants report 'Future Developments for Tenant Involvement in Cheltenham' be progressed with tenant and leaseholder representatives and stakeholders and a further report be brought back to Cabinet in July 2008. He drew particular attention to a number of key issues including:-

- The new group will represent both tenants and leaseholders the previous Federation just related to tenants, and leaseholders met separately
- The emphasis is on capacity building with tenants and leaseholders running a new organisation from their own place – a range if inspirational milestones have already been agreed as set out in 3.3 pf the report
- A new representative has been nominated for the Social and Community Overview and Scrutiny Committee

In recommending the report to Cabinet, the Cabinet Member Community Development and Housing report indicated that in his view there has to be an autonomous body that represents the interest of CBH's clients and whose role is to continually examine and constructively criticise the Council and CBH services. An effective independent tenants/leadseholders body with a mandate wider than just rents and repairs is key in this.

In response to a question from the Cabinet Member Built Environment, the Cabinet Member Community Development and Housing indicated that the body should be a spokesman not only for its current members but for the very idea of social housing. CBH were generally recognised for providing a good quality service and other Registered Social Landlords could learn from its experience and good practice.

The Cabinet noted progress made to date and the further recommendations for progressing the issue and referred the report to Social and community Overview and Scrutiny Committee for their consideration and recommendations.
