BT's proposal to re-align payphone provision to meet consumer demand.

BT gave notice to the council on 12th May that it was starting a 90 day consultation from 8th June 2008 to 6 September 2008 on proposals to remove 9 public payphones in borough of Cheltenham.

Phil Bennett and Jane Milton from BT Payphones attended the committee meeting on 5th June to provide some background to the proposals. The committee resolved to consult with Parish Councils and communities affected and co-ordinate a response on behalf of the Council.

An email was sent to parish councils, relevant ward councillors, statutory agencies and community organisations inviting them to comment on the proposals. Only one response was received from Gloucestershire Constabulary.

However, Jane Milton subsequently supplied the annual useage figures for each of the payphones which indicated that the most of the 9 had moderate to high useage and therefore we would claim that they were used by the local community.

The Ofcom guidance recommends that the relevant public body publishes its First Notification setting out its draft decision and sends a copy to the Secretary of State. We did this on 15th August with a closing date on Friday 29th August.

We now plan to issue our final notification in the week commencing 1st September. Our recommendations for each payphone and the reasoning are attached overleaf.
