I was prompted to email following a leaflet drop by Mr McAlary from Smith and Mann around our local area recently. There are several inaccuracies around the information in the leaflet and I wanted to ensure these were addressed by a local resident such as myself, rather than a local shop owner.

The proposed Lidl store would, in my view, not 'cause more congestion'. The Cirencester Road is already a busy road and those people living on the road would be used to noise traffic at all times of the day/night. Sainsburys store on Cirencester Road creates significant congestion as cars often queue up to enter the store, creating queues on both sides of the road. Despite this, Cheltenham Borough council still allowed Sainsburys to open a store there.

Having 80 parking spaces would help to reduce road congestion around the Lidl store, not necessarily add to it. This claim by the owner of Smith and Mann is rather contradictory, given the significant congestion that customers to his store already create around a very busy area of Charlton Kings. Parking around Smith and Mann is often very difficult and can be hazardous; people park on yellow lines around the shop very frequently and this seems rarely policed by traffic enforcement officers.

Taking jobs out of the community? Difficult to prove this either way but given the size of the proposal, am sure that a Lidl store is likely to create more jobs, not reduce them.

I live on the Beeches part of Charlton Kings and can assure you that it takes me considerably longer to drive to another Lidl store, than the 10 minutes stated in Mr McAlary's leaflet. Having a local supermarket the size of the proposed Lidl's store, would help reduce my carbon footprint as the car journey would take me about 5 minutes rather than the current 20 minutes.

I'm sure that Smith and Mann's provide a useful store to those local residents wishing to utilise their high prices and limited range of goods. However, I look forward to a local Lidl store being created for local residents that will provide both a greater produce range and keen pricing options that are currently unavailable to us in Charlton Kings.

I hope you will give full consideration to this objection along with many others who feel similarly about the building of a large new retail store that the area simply does not need.

I live in Bafford Approach and I would like to object strongly to this proposal. Here are my concerns:

1. The location is totally unsuitable. Traffic on the Cirencester Road is becoming a real issue and having an access point for this proposed store at this location is very dangerous as the nearby railway bridge obscures vision up the hill.
2. Car parking, through proposed, may be inadequate, causing illegal parking on the main road outside houses and further hazard. The local Sainsbury's mini-store further down the road has a ridiculously small parking area which regularly overflows onto the road along with the lorry access for restocking.
3. Traffic approaching Charlton Kings downhill from the Cirencester direction at 60mph, quickly faces a 40mph limit near the Golf Club then a 30mph limit soon after, on the approach to The Cheltenham Park Hotel entrance. From experience walking and cycling this route, I would estimate that perhaps 25% reduces speed sufficiently on the approach to the proposed entry point. Crossing this road is already difficult on foot as there are no crossing points unless you move further down the road past Bafford Approach.

4. Traffic already uses this road as a shortcut to the A417 and traffic increases massively when the Air Balloon roundabout and Hill area is closed, as is frequently the case. In these instances, lorries also use this route despite the official diversions that are put in place.
5. Schoolchildren numbers are increasing in the area and many use Bafford Approach to walk and cycle to school. Bafford Approach is already dangerous at commuter periods and weekends and this will significantly increase the problem making it busier throughout the day and evening.
6. Charlton Kings is well-served with grocery stores and supporting local business is a government priority I believe. Larger supermarkets are within 10-15mins drive and being realistic, even locals would drive to this new store so it has no benefit in reducing traffic levels. Also, the Post Office resides within a local grocery store and if this closed, would severely impact the least able-bodied and elderly people most of all.
7. Noise is a real concern, not just during construction (again which would likely see larger vehicles ignoring the correct routing (as still happens with the golf course work still progressing)).
8. Flooding is always a concern and siting a major store in an old railway cutting would be ridiculous without major disruption to the surrounding area. The Lilley Brook runs close to this site and already causes flooding issues downstream in bad weather as Leckhampton Hill (in the AONB) causes severe runoff.
9. Finally, I would like to suggest that other industrial brown field sites are considered if available. New housing developments are springing up everywhere and siting this store in the middle of an existing established housing area is not the way to go. If new roads are being built for new housing (as was done many years ago in the Gloucester Abbeymead/Abbeydale area, then this would be the correct place for a new store, including medical/chemist and other facilities (which seem to be overlooked during development)).

I hope the planning application is rejected and I have yet to talk to anyone in the area who supports this proposal.

I rely heavily on these small stores that I can access. I cannot deal with large stores and hence would lose my ability to shop if the Lidl was built.

I understand that Lidl has declined or otherwise not supported a retail impact statement. I fear that this delivers a very clear message that they are aware of the impact on our stores and/or they have no wish for this information to be assessed and relayed.

I also drive regularly in the CK village area and the imposition of a large new retail outlet with many car parking spaces would have a very negative impact on traffic flow and road safety.

I am aware that Lidl cites the goods it will sell and the prices it offers. If the community wishes to use Lidl's services, there is already one in town - as there are many local supermarkets.

We do hope there is still a point in writing this as, having already seen the removal of several large trees connected with the site and this now leaving us with a clear view of Cirencester Road, it's to be hoped they are not shortly to be replaced by large blue and yellow signs. We will remember the days when we were made to jump through hoops by the council in order just to have a few trees cut back in our own garden which does seem to suggest the height of hypocrisy. That's before we even mention the change in noise pollution levels from Cirencester Road at this stage and before we even consider a constant flow of lorries and cars that Lidl would bring.

Our other reasons for this objection are:

- (1) Cheltenham does not need yet another Lidl store and this one will create issues with both traffic levels and safety at the bottom of a hill. As mentioned, there is also likely to be an increase in noise levels, often during unsociable hours in what is primarily a quiet residential area.
- (2) Having previously worked at offices on this site, we can confirm that flooding of the car park was regularly an issue and we always suffered from problems with the infrastructure of the building. Another large building on this site will surely only add more strain.

- (3) When planning was granted by the council for the Sainsbury's site, we warned of the effect it would have on other businesses and indeed the local store on the other side of the road closed shortly afterwards and has remained an empty site ever since. There will clearly be a similar issue with other businesses in the area this time around and, who knows, Sainsburys might well become unviable and another derelict property might soon arise. In any case, the new superstore is bound to have a negative impact on other businesses and associated jobs.

We trust the Planning Committee will be taking a detailed look at all of the points being raised by numerous people and have the courtesy to correspond with those closer affected by their decisions.

My wife and I have received a letter from Lidl seeking our support for their proposed new store in Charlton Kings, and I am afraid that we cannot do this.

Since the beginning of Covid, and still currently, Smith and Mann have offered, and provided us, free of charge, with home delivery of online grocery supplies from their store. Aged 90 and 91 as we are, it is true to say that their support has proved a life-saver to us, and we shall continue to support themj in return.

We find it incomprehensible for the Council retail adviser to give the opinion that a new store would not adversely affect the existing ones. NISA at the Croft Road junction with Cirencester Road closed within a few weeks when Sainsburys appeared opposite them. In any community such as Charlton Kings, with a finite number of residents, new competition cannot fail to disadvantage retail outlets. There is only so much demand and a new store will not bring with it new customers to the area.

The Lidl letter says Lidl often enhances footfall within a local centre, to the benefit of all retailers. This certainly will not be so in this local situation. The existing shops are all at the centre of Charlton Kings, while the proposed new Lidl is to be on the outer periphery. Any new travel to the store will be by car away from Cheltenham up the Cirencester Road, causing an obvious increase in traffic pollution.

Lidl already have three outlets in Cheltenham. Presumably they are aiming for Charlton Kings because Sainsburys have appeared here.

We note that the letter admits that objections to the Council about the proposed new store outnumber the letters of support, and we would like to add our names to the opposition, hoping that you will see fit to refuse the application.

1. The store has refused to do a retail impact statement. In my view this is unreasonable and shows that the company has no respect for local feelings and the procedure whereby Cheltenham Borough Council has requested such a statement.
2. Many local folks including the elderly who live in Charlton Kings use the small local shops on a daily basis and these are likely to be put out of business by the proposed new store. Many walk to the local shops in the village. However, the new store, if built, will mean a car journey as it is too far to walk for many elderly, especially if carrying heavy shopping.
3. The local post office in Charlton Kings will most likely leave the village of Charlton Kings and the nearest one, if this happens, is a bus ride away, or two bus rides. This may not impact on car drivers but for those who do not drive but it will certainly impact on them and mainly the elderly and disabled.
