I have had meetings from 12pm UK time and am therefore late in my e mail to you. There are several issues that are of concern. Some of them are: Traffic: Would it be possible to have the entrance to the site from Swindon Farm, or Tewkesbury Rd? The issue of traffic going through the village is of great concern. Heritage: i am not happy at the virtual dismissal of heritage assets and historic sites that have not been fully explored. Can this be rectified? Flooding potential is also causing some anxiety; Sustainability of the site. Nowhere is it evident that broadband has been put in, nor that the houses and flats are at acceptable ecological and carbon standards. This would be an ideal opportunity to build - as in other places - virtual carbon neutral homes. A réduction is not enough. Incidentally, the recognised international sustainability criteria, includes the current community, not just the cash flow of the developer. How is the current community to be sustained? What about electric car charging points being built in? Paths need to allow a pram and a pedestrian to pass one another 3m or thereabouts - I don't see that on the plans. Schools: Where are children to be educated?
