For clarity given proposed modifications and links to appendices, the recommendations to the Council are therefore now as follows:

- 1. Adopt the Cheltenham Borough Council Community Infrastructure Levy Charging Schedule modified in line with the recommendations of the Independent Examiner, <u>as set out in the Modified Appendix A 'Charging Schedule' and 'Policy Maps' at Appendix B.</u>
- 2. Adopt the following supporting policies:
- a. Payment by Instalments (Regulation 69b), <u>as set out in the Modified Appendix D</u> 'Payment by Instalments' Policy
- b. 'Request for Review and Appeals' Policy (Part 10), as set out at Appendix E
- 3. Approve the Regulation 123 List for Cheltenham Borough Council for publication, as set out at Appendix F
- 4. Set a commencement date for charging of 1 January 2019, in line with Joint Core Strategy (JCS) partner authorities

SUPPLEMENTARY STATEMENT TO APPENDIX A EXPLAINING AMENDMENTS

PROPOSED AMENDMENT:

Replacement of Appendix A 'Charging Schedule with the Modified Charging Schedule attached. In the Modified Charging Schedule:

- a. Affordable Housing requirements have been removed from the table of charges at Table 1.1.
- b. The '11 dwellings and over' charging category for Generic Sites within Table 1.1 has been changed to 'between 11 and 449 dwellings'.
- c. An additional paragraph (5.4) has been added making reference to the policy maps.

REASONS

Affordable housing requirements were included in consultation versions of the document but should not have been included in the final version.

The description of the '11 dwellings and over' in the Generic sites charging category has been corrected in line with the Examiner's recommendations to reflect the additional category for 450 dwellings and over.

Policy maps, identifying the location of the Joint Core Strategies' Strategic Allocations, are included in the Council Report as Appendix B but will need to become an appendix of the Charging Schedule on adoption to satisfy regulatory requirements.

SUPPLEMENTARY STATEMENT TO APPENDIX D EXPLAINING AMENDMENTS

PROPOSED AMENDMENT

Replacement of Appendix D 'Payment by <u>Instalments'</u> policy with Reviewed Payment by Instalments Policy as below, replacing Table 1; schedule of instalments.

- a. For CIL liability of £100,000 or less 100% will now be due in one Instalment in 18 months from commencement of development, rather than 50% within 60 days of commencement of development and 50% within 6 months of commencement of development.
- b. For CIL Liability between £100,001 and £1,000,000 10% will now be due within 60 days of commencement of development and two further instalments of 45% will be due at 6 and 12 months from commencement of development, rather than 33% within 60 days, 6 months and 12 months of commencement of development.
- c. For CIL liability of £1,000,000 and above 10% will now be due within 60 days of commencement of development and three further instalments of 30% will be due at 6, 12 and 24 months from commencement of development, rather than 25% within 60 days, 6 months, 12 months and 24 months from commencement of development.

REASONS

Proposed in recognition of concern regarding developer cash-flow.
