

1. DESCRIPTION OF SITE AND PROPOSAL

- 1.1 This application seeks planning permission for a change of use of two fields which adjoin the existing Cemetery and Crematorium which is located off Bouncer's Lane.
- 1.2 The land is owned by Cheltenham Borough Council and was acquired for the purposes of future cemetery use in 1945, but an application has not been made to change the use of this land to date. The application has been submitted as Cheltenham Cemetery currently has burial capacity for approximately 10 years within its existing boundaries and therefore there is a requirement to plan for future needs.
- 1.3 The proposal is a cross boundary application which is also being considered by Tewkesbury Borough Council. Essentially, all of the land to which the change of use relates lies within the administration of TBC, however the red line of the application site extends to the public highway, which relates to land within Cheltenham Borough Council's administrative boundary.
- **1.4** Due to the nature of the site spanning two administrative boundaries, the application being considered by CBC will relate only to the suitability of the access arrangements.
- **1.5** The application is before Committee as Cheltenham Borough Council is both the landowner and the applicant.
- **1.6** The recommendation is to permit this application. The officer comments section of this report will follow by way of an update.

County Archaeology

In connection with the above planning application I wish to make the following observations regarding the archaeological implications of this scheme.

I advise that I have checked the proposed development area against the County Historic Environment Record, and there is no evidence for any previous archaeological investigation there. However, the wider locality is known to contain extensive archaeological remains relating to prehistoric and Roman activity and settlement. Such archaeological remains are often covered, and so masked from view, by medieval and modern plough soils.

Against that background, and in view of the large size of the application site (c 2.5 ha), I have a concern that significant archaeological remains relating to prehistoric and Roman activity and settlement may be present within the proposed development area, and that any such remains would be adversely affected by ground works and intrusions required for the use of this land as a cemetery.

Therefore, in accordance with the NPPF, paragraph 128, I recommend that in advance of the determination of this planning application the applicant should provide the results of an archaeological field evaluation which describes the significance of any archaeological remains contained within the site and how these would be affected by the proposed development.

I look forward to advising you further when this information is made available.
