- No retail sale of alcohol may be made under the premises licence:
  - (a) at a time when there is no designated premises supervisor in respect of the premises licence, or
  - (b) at a time when the designated premises supervisor does not hold a personal licence or his personal licence is suspended. holds a personal licence.
  - (d) The other conditions are any conditions specified in an order under section 19A and applicable to the premises licence.

### Annex 2 - Conditions consistent with the Operating Schedule

- In accordance with Schedule 8 paragraph 6(6) and (8) the embedded conditions and restrictions which apply to the existing licence(s) are preserved in this licence including:
  - (a) Recorded music is permitted by virtue of s.182 of the Licensing Act 1964
  - (b) Late night refreshment beyond 23.00 hours is permitted by the virtue of the Late Night Refreshment Houses Act of 1969
  - (c) A 30 minute 'drinking up' time shall be provided to allow appropriate dispersal, use of lavatories etc.
- 2 (a) There shall be no sale, supply or consumption of intoxicating liquor to or by cutomers not seated within the premises and any such service shall be by waiter/waitress or bartender only.
