## Certification of grants and returns 2010/11 Summary of certification work outcomes

Overall, we certified 6 grants and returns:

- 4 were unqualified with no amendment;
- 1 was unqualified but required some amendment to the final figures; and
- 1 required a qualification to our audit certificate.

Detailed comments are provided on page 4.

Detailed below is a summary of the key outcomes from our certification work on the Council's 2010/11 grants and returns, showing where either audit amendments were made as a result of our work or where we had to qualify our audit certificate.

A qualification means that issues were identified concerning the Council's compliance with a scheme's requirements that could not be resolved through adjustment. In this circumstance of the qualification detailed in number 1 below, it is unlikely that the relevant grant paying body will require further information from the Council as a result of the minor technical qualification.



	<ul> <li>Minor amendments of £5,322, were required to ensure that the claim presented for audit reconciled to the Housing Benefits system.</li> </ul>	
	As in previous years a qualification report was issued to reflect that the benefit granted figures in the claim form and the benefit granted figures used in the reconciliation differed by £303. As in previous years, officers had identified and corrected the adjustments before submitting the form to DWP and to audit; however, the instructions to auditors require that we report the difference in the reconciliation.	
2	Housing Subsidy Base Data Return	£0
	The number of shared ownership non PFI dwellings on 1 April 2011 (cell F002DS) had been incorrectly entered into Cell F002DP (the number of PFI dwellings which were <i>not</i> shared ownership dwellings on 1 <sup>st</sup> April 2011).	
	The claim was updated to reflect the correct underlying data.
