I cannot believe that an application for the change of use of premises such as this is being considered for a building that shares two sides with Grosvenor Place South where I reside. Our residential street has many families with young children.

Roxy Lanes – 'Booze and Ball Games' [their wording not mine] – is a late-night adult entertainment venue totally unsuited to this location. I do not see how the approval of this application can be reconciled with stated council policy of protecting children from harm [being woken late at night on school days], preventing public nuisance [late night drunken, disorderly behaviour] and preventing crime and disorder [it a matter of police and public record that our street has suffered numerous instances of threats to public safety and damage to property associated with the vandalism at Centre Town East car park]. I only foresee an increase in such anti-social behaviour in our residential street if this late-night licence application is granted.

I am unable to make my comment on the planning portal so please can you confirm receipt of this email

I object to this application on the basis of preventing further public nuisance and crime and disorder in the residential area Grosvenor Place South which is directly behind the proposed premisis for this application.

Grosvenor Place South a residential no through road and is accessed from the High Street via two alley ways - one leading to Grosvenor Terrace (at the rear of the properties by the Town Centre East Car Park) and the other to Grosvenor Place South itself. As residents we are regularly subject to public nuisance and anti-social behaviour as a direct result of late night revellers making their way off the high street. While the venues on the High Street provide security personnel to maintain order immediately outside their premises they have no interest in what happens once customers leave the immediate area and enter either of the alley ways leading to Grosvenor Place South / Grosvenor Terrace.

In the evenings these alleys are used as urinals, for drug taking and are constantly covered in graffiti. Often groups walk up the road singing, shouting, arguing and consequently waking those who live in Grosvenor Place South. Approving another license premises in the immediate area will only compound these issues.

In the past year the Council has spent significant financial resources attempting to reduce crime and disorder in this areas, specifically in Grosvenor Terrace and the Town Centre East Car Park.

I understand the Council's need to prioritise keeping the High Street occupied with businesses but this should not be to the detriment of local residents and other businesses. Currently Flight Club, Mr Mulligans and Hollywood Bowl are all business in the Brewery Quarter offering similar experiences to that proposed by Roxy Lanes but with less extensive opening hours. Would approving this give Roxy Lanes a competitive advantage? Could it result in these other businesses closing down as there is a limited market for this type of entertainment?

There does not yet seem to be an application for change of use on the Planning Portal to understand the size of the proposed business, its capacity, its access points - all of which are key factors to the impact on local residents and other businesses.

Please do not approve this application without considering the inevitable increase in public nuisance and anti-social behaviour it will bring to local residents and understanding the capacity of the venue and its entry and exit points.

I'm writing to register my objection to the application made by Roxy Leisure for a New Premises Licence for the building 103-109 High St, GL50 1DP.

This premises, currently the site of a New Look clothes store, backs on to the end of our street, Grosvenor Place South, and is situated roughly 30 metres from our home. The residents of our street are extremely concerned about this new licensing application and the detrimental impact granting it will inevitably have on the quality of life in our street.

Grosvenor Place South is a residential cul-de-sac that is home to a mixture of families, older residents and young professionals. Though we are very close to the High Street, the street is very quiet, especially at night after the shops are closed. Despite this, we have had a number of reported issues in the recent past including vandalism and unruly behaviour, damage to vehicles and to the rear of our property. We have also experienced a significant number of issues connected to the multistorey car park adjacent to our street and occasionally from late night drinkers returning home from the pubs and clubs at the top end of the High Street.

We know from past experience that the licensing of a new premises - one that actively promotes itself as an **all-day (from 11am)** and late night drinking and gambling establishment (2am on Friday and Saturday nights), including the request for a licence for entertainment that will include films and recorded music – so close to our home will impact significantly on the quality of life and the safety of residents in our street, several of whom are elderly.

This is a large commercial premises with the potential for a significant number of patrons. It is situated within 50 metres of our family home. Though the front of the property is on the High Street, the alleyway beside the property and its extensive and poorly lit rear access area will inevitably become host to drunken behaviour and nefarious late night activities. There are many other pubs and club on the High Street and Bath Road already, some of which are struggling to make a profit. I do not see that there is any justification for another at this time – especially one that will clearly bring with it a considerable number of antisocial issues.

Therefor I am objecting to this licensing application in the strongest terms. I would request that you acknowledge and consider this and other requests from concerned residents before agreeing to grant this or any other licence for this premises.

I am writing to complain about a recent application by Roxy Leisure Ltd to introduce a nightclub into the New Look building, 105-107 High Street, Cheltenham, Gloucestershire GL50 1DW. My home is on Grosvenor Place South and is within 30 metres of the back of the New Look building. I strongly object to the application based on the extra vehicular traffic, noise, drunken behaviour and fighting which will inevitably result from this licence being granted.

Our street is a quiet cul-de-sac which has a combination of families and pensioners living in it. We have had significant issues over the years with the noise and multiple disturbances in the multi story car park which is behind our house. In addition we have been worried about the change of use of the old Lidl building to a storage facility. There have, on occasions, been incidents of drunken behaviour, drug consumption and fights in our street as the alleyway to the High Street leads onto Grosvenor Place South. On one occasion, our garage door was literally kicked in costing hundreds of pounds of damage. The level of disturbance that we already put up with should prove that there are enough drinking establishments already at this end of the High Street. There is no need for this licence to be issued.

"Clubbers" can come & go from choice but we residents / the neighbours of this establishment who live in the areas closely surrounding the property, will suffer continually from any noise with no time off Grosvenor Place South being one of the streets virtually an arms length away with the closest residents being almost "next door neighbours!!" Day in & day out. 7 days a week!
- 1. It is a Residential area in a Conservation area! Noise & rowdy behaviour is unacceptable.

- 1. Music & clubbers will frequent our quiet mostly peaceful streets outside our homes as they will inevitably wander & continue to party further afield i.e outside our homes until the early hours plus throughout each day & will cause disturbances for residents particularly for the babies, young children & elderly who live here.
- 1. The size of the property is enormous! The numbers will be many. Having looked closely at all their other clubs around the country there is a very high chance that we will suffer noise & disturbance from their "entertainment, films & recorded music" being pumped out day & night 7 days a week together with further noisy "merrymaking" after hours.
- 4. Last but definitely not least I am aware that Drugs & Crime here might well become a No 1 grave concern for us & could become a very serious issue with the influx that large numbers of people including the usual intoxicated undesirables etc who are attracted to clubs.
