Executive summary:

The Local Government Boundary Commission for England (LGBCE) has completed its review of the electoral arrangements for Cheltenham Borough Council and The Cheltenham (Electoral Changes) Order 2023 was made on 18 July 2023. The changes will be effective on 2 May 2024, but for the purpose of proceedings relating to the election, changes to the register can be made from 15 October 2023. As a result of the new warding patterns new polling districts will be required.

The Boundary Commission for England (BCE) has concluded the 2023 Review of Parliamentary constituencies. The Order making the changes is expected to be made by 31 October 2023, after which the new constituencies will be effective at the next UK Parliamentary General election. The recommendations relating to the Parliamentary constituencies are subject to the order being made.

The Council has a statutory duty to review its polling districts, polling places and polling stations, to ensure that all electors have such reasonable facilities for voting as are practicable and to ensure that the polling stations are accessible to all electors including those with special needs.

A consultation exercise has been completed and consideration has been given to the views put forward.

- Charlton Park Ward creation of new polling district ED and for electors to vote at Cheltenham East Community Fire & Rescue Station, Keynsham Road for all elections except for County Council by election when the electors will vote at Holy Apostles Church Hall, London Road
- Charlton Park Ward creation of new polling district EE and for electors to vote at Old Patesians Sports and Social Club, Everest Road for all elections except for County Council by election when the electors will vote at Leckhampton Primary School, Hall Road
- College Ward creation of new polling district FD and for electors to vote at Portakabin, Town Hall, Imperial Square for all elections except for County Council by election when electors will vote at St Gregorys Old Priory, 70 Clarence Street
- College Ward creation of new polling district FE and for electors to vote at Emmanuel Church, Fairfield Parade for all elections except for County Council by election when electors will vote at Leckhampton Baptist Hall, Pilley Lane

- Prestbury Ward polling district MB to change the polling station from the Portakabin and for electors to vote at the Committee Room, St. Nicolas Church Hall, Swindon Lane
- Prestbury Ward creation of new polling district MC and for electors to vote at Prestbury Hall, Bouncers Lane for all elections except for Parliamentary election when electors will vote at Pittville Pump Room East/West Approach Drive

- Up Hatherley Ward creation of new polling district SE and for electors to vote at St Margarets Hall, Coniston Road for all elections except for County Council by election when electors will vote at The Annexe, St Margarets Hall, Coniston Road

- Warden Hill Ward creation of new polling district TD and for electors to vote at The Annexe, St Margarets Hall, Coniston Road for all elections except for County by election when electors will vote at St Stephens Parish Church, St Stephens Road

Any changes to the polling districts, polling places and polling stations must be made in accordance with the provisions of the Representation of People Act 1983 (as amended), Electoral Registration and

Administration Act 2013 and Equalities Act 2010.

The council must seek to ensure that all electors in a constituency in the local authority area have such reasonable facilities for voting as are practicable in the circumstances. The council must seek to ensure that so far as is reasonable and practicable every polling place for which it is responsible is accessible to electors who are disabled

2 Background

- 2.1 The Local Government Boundary Commission for England (LGBCE) has completed its review of the electoral arrangements for Cheltenham Borough Council. New polling districts will need to be created and implemented in the new wards. An interim review was undertaken to ensure that all electors have reasonable facilities for voting as are practicable and to ensure that the polling stations are accessible to all electors including those with special needs. The Acting Returning Officers for the Cheltenham and Tewkesbury constituencies (for the area within the Borough of Cheltenham) have made formal comment as part of this review, both to existing polling stations and the polling stations that would probably be used based on the newly recommended polling places.
- 2.2 What is not being reviewed The Cheltenham and Tewkesbury Parliamentary constituencies, Gloucestershire County Council electoral divisions, Cheltenham Borough Council wards, Parish and Parish ward boundaries

3 Reasons for recommendations

3.1 To ensure that all electors have reasonable facilities for voting as are practicable and that the polling stations are accessible to all electors in the new borough wards.

4 Alternative options considered

- 4.1 In Battledown Ward for polling districts BA and BC a number of venues were explored but deemed unsuitable as set out in the paragraphs below.
- 4.2 Charlton Kings Cricket Club was deemed to have inadequate accessibility due to steep hill, no pedestrian path and limited street lighting as well as being a substantial distance from most of the properties in polling districts BA and BC.
- 4.3 Holy Apostles Church Hall although a suitable venue, is situated south west of the ward a substantial distance from many of the properties in polling districts BA and BC. There is no direct bus route for electors who may need to use public transport.

5 Consultation and feedback

- 5.1 Following the closing date for the review, as well as the formal comments from the Parliamentary Returning Officers for Cheltenham and Tewkesbury constituencies (see paragraph 5.6 below) correspondence was received from sixty six other sources.
- 5.2 For Battledown Ward polling districts BA and BC, sixty comments were received from electors stating that they did not want Holy Apostles Primary School to be used as a polling station and that an alternative should be used. Seventeen of these supported the move to Cheltenham Cricket Club. Four of these suggested Holy Apostles Church Hall as an alternative, one also suggested Highbury Church Hall or Cheltenham Football Club and one suggested Queen Elizabeth Park. One elector requested that Holy Apostles School should remain the polling station.
- 5.3 For Leckhampton Ward, Councillor Martin Horwood commented that the three polling stations are well located for the polling districts they serve and should not be changed again, especially as there have already been recent changes.
- 5.4 For Swindon Village Ward, Councillor Flo Clucas commented that no changes have been proposed to the existing polling stations for the ward and confirmed her agreement.
- 5.5 For Up Hatherley Ward, comments were received from Councillor Adrian Bamford in accord with Councillor Julie Sankey, County Councillor Roger Whyborn and Up Hatherley Parish Council. All support the proposed changes to polling district SA and SC but in addition to the proposed changes all recommended transferring more properties into the new polling district SC from SA to include 2-28 Caernarvon Road, 282- 304 Hatherley Road, Flint Road and Glamorgan Road. For the new polling district SA, all supported the move from St Philip and St James Church Centre to St Margarets Hall, Coniston Road. They also recommended transferring 77-151 Caernarvon Road from polling district SA to polling district SB so that these electors will vote at Hillview Community Centre, Hulbert Crescent.
- 5.6 Responses from the Acting Returning Officers (ARO) for Cheltenham and Tewkesbury constituencies A full list of the proposed Cheltenham constituency polling districts and polling places / stations is set out in appendix 2 and the proposed Tewkesbury constituency polling districts and polling places / stations is set out in appendix 3 along with the AROs comments.
