## **2 Background**

2.1 The Anti-social Behaviour, Crime and Policing Act 2014 introduced several new tools and powers for use by councils and their partners to address anti-social behaviour (ASB) in their local areas.

2.2 The Act gives councils the authority to draft and implement PSPOs in response to the particular issues affecting their communities, provided certain criteria and legal tests are met:

2.2.1 activities that have taken place have had a detrimental effect on the quality of life of those in the locality, or it is likely that activities will take place and that they will have a detrimental effect

2.2.2 the effect or likely effect of these activities:

2.2.3 is, or is likely to be, persistent or continuing in nature

2.2.4 is, or is likely to be, unreasonable

2.2.5 justifies the restrictions being imposed.

2.3 Outlined in Appendix 3 is evidence provided by Gloucestershire Constabulary identifying the issues and adverse impact this is having on the local community.

2.4 Councils can use PSPOs to prohibit specified activities, and/or require certain things to be done by people engaged in particular activities, within a defined public area. The legislation provides for restrictions to be placed on behaviour that apply to everyone in that locality (with the possible use of exemptions). Breach of a PSPO without a reasonable excuse is an offence.

2.5 In this case, it is proposed that the Public Spaces (Cheltenham) Order 2023 be amended to include the specified area on Tennyson Road (2.5) in the specified areas where a “Prohibition of alcohol consumption designated areas” (Schedule 1 (Designated areas)) applies.

2.6 The proposed area to be included on Tennyson Road is shown in appendix 4.

### **3 Reasons for recommendations**

3.1 To respond to increasing issues associated with street and public consumption of alcohol that gives rise to alarm, distress and harassment in the local community.

### **4 Alternative options considered**

4.1 The Cabinet Member for Safety and Communities can decide not to approve consultation as outlined in this report.

### **5 Consultation and feedback**

5.1 Before introducing, extending, varying or discharging a PSPO, there are requirements under the Act regarding consultation, publicity and notification.

5.2 Local authorities are obliged to consult with the local chief officer of police; the police and crime commissioner; owners or occupiers of land within the affected area where reasonably practicable, and appropriate community representatives. Any county councils (where the Order is being made by a district), parish or community councils that are in the proposed area covered by the PSPO must be notified.

5.3 There are no statutory requirements about the length of the consultation process. However, it should be ensured that its duration allows sufficient time to meaningfully engage with all those who may be impacted by the Order.

5.4 In this case, it is proposed that a 4-week consultation be undertaken principally

based on the fact that the geographical area proposed to be included in the varied PSPO is small.

5.5 Delegation to consider consultation feedback and the decision whether to vary the Public Spaces (Cheltenham) Order 2023 sits with the Director of Governance, Housing and Communities, in consultation with the Cabinet Member for Safety and Communities.


