The Designated Premises Supervisor (DPS) shall maintain an active membership of the Nightsafe / Cheltenham Innkeepers Association (or successor 'pubwatch' body).

Six colour CCTV cameras will be installed covering the internal and external areas of the premises.

The CCTV system shall be maintained in a good working order, shall record at all times that the premises are open, and recordings shall be kept for 14 days and be provided to authorised officers of the council and the police on request.

On the second and third floors, alcohol will not be sold otherwise than to persons taking table meals there and for consumption by such a person as ancillary to their meal.
